Old Business

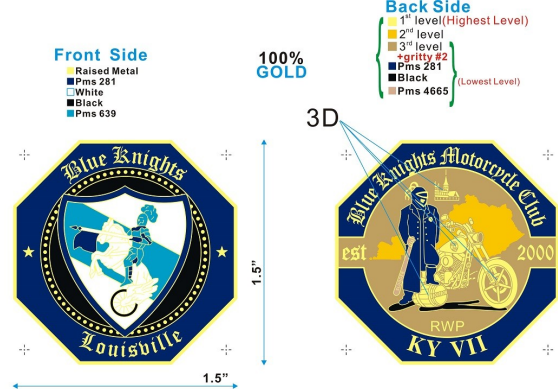
